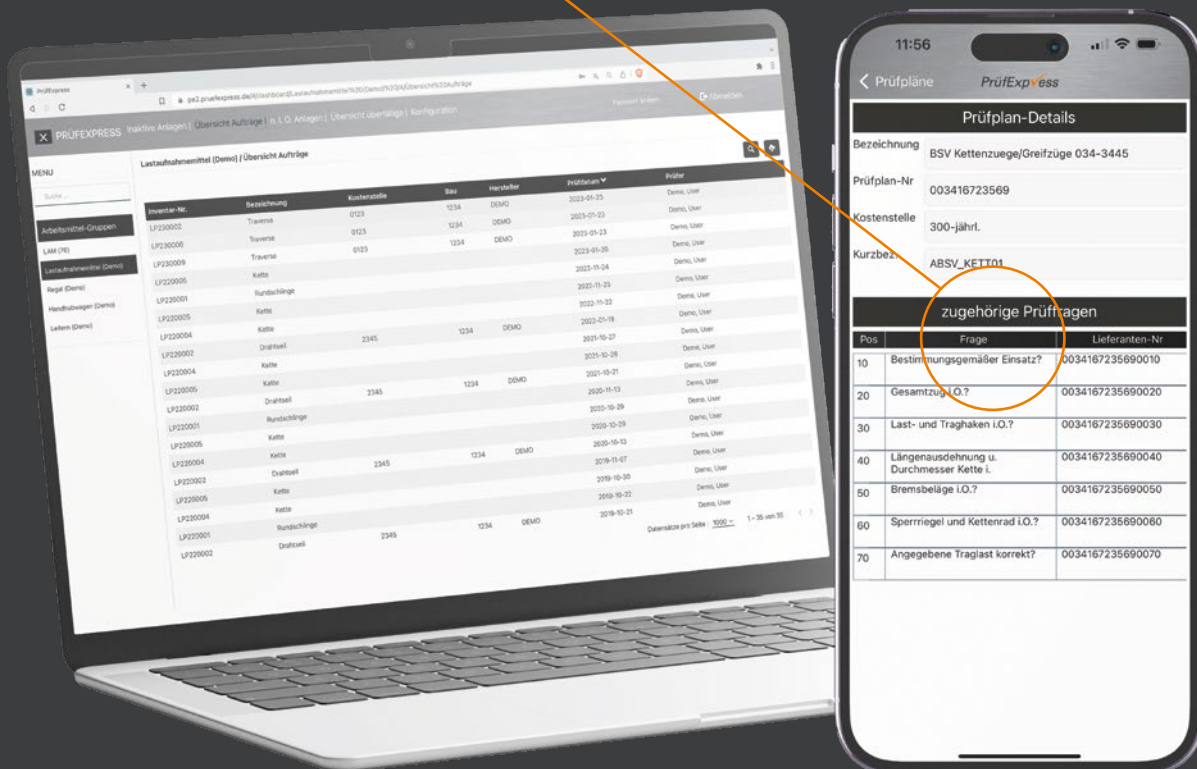

Prüfexpress | Legal basis

The inspection obligation for work equipment is stipulated in § 14 of the German Ordinance on Industrial Safety and Health (BetrSichV) paragraph 1 and 2.

§ 14 Inspection of work equipment

(1) The employer must ensure that work equipment, whose safety depends on the installation conditions, is inspected by a qualified person before being used for the first time. The inspection includes the following:

1. Checking that the assembly or installation complies with regulations and that this work equipment functions safely,
2. The timely identification of damage,
3. The determination as to whether the safety measures taken are effective.

Inspection contents that have been tested and documented as part of a conformity assessment procedure do not need to be re-inspected. The inspection must be before each commissioning following an assembly.

(2) The employer must have work equipment that is exposed to damage-causing influences, which may lead to hazards for employees inspected periodically by a person authorised to inspect it. The inspection must be carried out in accordance with the intervals determined in accordance with § 3, paragraph 6. If the inspection shows that the work equipment cannot be operated safely until the next periodic inspection determined in accordance with § 3, paragraph 6, the inspection interval must be adjusted.
